Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

- 1. Skill Development Programs for Students and Scholars: Second party will give valuable inputs to the First Party in imparting online and onsite training programs on Research Methodology, basic statistics and the emerging technologies in order to bridge the skill gap in academia and research. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein. There is no financial commitment on the part of the St. Thomas College of Education, the First Party to take up any programme mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

The agreement shall be valid for three academic years from the date of signing the agreement unless renewed or extended in writing. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be





construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
